

2025 MEMBERSHIP FEES & RATES

MEMBERSHIP TYPES:

Individual Membership - A single adult (18 years of age and older) or single parent with children born after October 1, 2022.

2 Person Membership - Husband and wife, or a single parent with a child 3-23 years of age **residing at the same address**.

Family Membership - Three or more family members including any combination of husband, wife, and children (3-23 years of age and single) **all residing at the same address**. **Children are defined as tax dependents of the membership holder.**

MEMBERSHIP PLANS:

Plan A - Full Membership

May 24th through September 1st

Includes all available full-time privileges, including year round tennis.

Plan B - Weekdays Only

May 26th through September 1st

Includes Memorial Day, Independence Day (July 4th), & Labor Day

Guest fees must be paid at all other times.

APPLICATION FEE & RE-ACTIVATION FEE: \$50.00

Non-refundable.

Payable at time of application and by former members who have been inactive for one or more years.

INITIATION FEE: Individual: \$250.00 2 Person and Family: \$500.00

Non-refundable. Payable one-time only at time of acceptance into club membership.

BABYSITTER PASS: \$225.00 per person

Maximum of two sitters may be registered. **Sitters must be 17 years or older AND have a valid driver's license.** (Please submit a photocopy of sitter's driver's license with application.) Sitter must accompany or be accompanied by a registered member of the family and must sign the babysitter agreement. **Senior discount may NOT be applied to Babysitter Pass**

SITTERS ARE REQUIRED TO SUPERVISE CHILDREN 15 YEARS OF AGE & UNDER when parents are not present.

MISCELLANEOUS:

- Children 2 years old and under (born after October 1, 2022): No Charge**
- Guest Fees: \$10.00 Monday - Friday; \$15.00 Saturday & Sunday; \$20 Holidays (Memorial Day, 4th of July, Labor Day)**
Per person. **Non-refundable.** Due immediately upon arrival. \$5.00 off after 5 p.m. except during Special Events.
- Senior Citizen Discount: \$50.00**
Individuals 62 and over as of May 1, 2025. **Not applicable for Babysitter Pass or Dependent Parents.**
Proof of age (i.e. Copy of driver's license) must be submitted with application.
- Dependent Parents: No Charge**
Dependent parents residing at the same address will be admitted at no charge. Proof of residency is required at time of application. (i.e. Copy of valid driver's license) **Senior discount NOT applicable for Dependent Parents.**

PAYMENTS:

- Acceptable forms of payment include cash, check, VISA, MasterCard, Discovery and AMEX.
- Credit card payments will incur credit card processing fees of approximately 3%.**
- Returning members must submit all fees & dues in full prior to April 1st to be guaranteed membership.
